DO NOT bring items to the event unless previously approved. On the day of the event, representatives of the Town of Darien will be monitoring compliance. Vendor has read, understands and will abide with ROCKtoberfest general information, procedures, rates and conditions. By signing this application, the vendor acknowledges that the event is subject to various weather conditions and State and Federal Safety and Health Regulations.

No refund of application fees will be given if the application is accepted by ROCKtoberfest 2021.

Exhibits must remain open until closing. There is no electrical service available.

The Town of Darien reserves the right to refuse any application. Submission of this application does not guarantee a space.

This Agreement may be terminated by The Town of Darien with or without cause immediately upon notice to Vendor. Vendor and its employees, personnel, and agents agree to be bound by the terms of this Agreement and all Event rules, regulations, and directives.

Vendor will act with the highest regard for the safety of the attendees and other Vendors of ROCKtoberfest, and will adhere to all laws, policies, rules, and regulations applicable to the goods and/or activities of Vendor, including obtaining all licenses, permits, and approvals that may be required to enable Vendor to conduct its activities at the event and fulfill its obligations under this Agreement.

Vendor represents that it has, or will have at the time of the event, appropriate insurance to cover liability for the types of activities Vendor will conduct at the event. Vendor covenants to be fully responsible for any of its liabilities, actions, or omissions, and will indemnify, defend, and hold The Town of Darien (and its officers, employees, agents, vendors, affiliates, and representatives), Darien Arts Center and the harmless against any claims related to Vendor's liabilities, actions, or omissions.

The date of the event is October 2, 2021 from 12:00-6:00 pm with a scheduled rain date of October 9th, 12:00-6:00 pm. There will be no refund of fees due to weather conditions, whether they occur on the scheduled day or the rain date.

If the event is cancelled due to unforeseen circumstances, there will be no refunds of Vendor Fees.

If Vendor cancels its participation up to one week prior to the event, then The Town of Darien will offer a 50% refund. If Vendor cancels its participation in the event within one week prior to the event, then The Town of Darien cannot offer a refund, due to the administrative work already done by that time. Once Vendor cancels, it forfeits its spot in the event.

Vendor may not assign this Agreement to any third party, or delegate any of its obligations without the written consent of The Town of Darien. Only the accepted Vendors are able to sell or distribute their items and/or conduct activities at the event. The vendor list, map, and Booth assignments are subject to change without notice. The Town of Darien does not guarantee any level of attendance at the event and there will be no refunds, under any circumstances, after the event is over.

The terms of this Agreement may be changed by The Town of Darien and notice of such change(s) will be sent to you in writing. You agree to accept notices via email, sent to the address indicated below. The Town of Darien reserves the right to decline, prohibit, or expel any Vendor exhibit, or prevent any activity, displays, product, or conduct, which (in The Town of Darien's sole judgment) is out of keeping with the character of the event or endangers the venue, any attendee, or other Vendors.

Vendor and its agents, employees, personnel, and/or independent contractors who participate in the event agree to be bound to this Agreement. The terms of this Agreement, including any waivers, inures to the benefit of The Town of Darien and its affiliates and ROCKtoberfest co-producers and sponsors.

The relationship of Vendor to The Town of Darien is that of an independent contractor, and nothing contained in this Agreement will be construed as creating a partnership, joint venture, employment relationship, agency, or other relationship between the parties, or to make The Town of Darien liable for the debts or obligations of Vendor.

Further, you hereby affirm that you have been well advised and thoroughly informed of the inherent hazards and policies of ROCKtoberfest 2021. You know that by participating in the ROCKtoberfest 2021, you are exposing yourself to certain known and unknown liabilities in your direct and indirect actions with the public and invitees of the event. You also understand that if you choose to hire help for ROCKtoberfest 2021, you are directly responsible for their actions or injury.
